Hereby enter into the following Agreement:

1. **Agency; Purposes.** The Artist appoints The Contemporary Art Modern Project, llc as agent for the works of art ("the Artworks") consigned under this Agreement, for the purposes of exhibition and sale at (exhibition)_____.

The Contemporary Art Modern Project, llc shall not permit the Artworks to be used for any other purposes without the written consent of the Artist. This agreement applies only to works consigned under this Agreement and does not make Contemporary Art Modern Project, llc a general agent for any other works.

2. **Representation.** The Artist hereby appoints The Contemporary Art Modern Project, llc as their representation throughout "Specific area" to sell or otherwise make available for acquisition to the public, the Artist's Artworks.

3. Consignment. The Artist hereby consigns to The Contemporary Art Modern Project, llc on consignment, those Artworks listed on the attached Inventory Sheet, which is a part of this Agreement.

4. Authority of Accepted Artist's Works. Works of art may be accepted for consignment only by The Contemporary Art Modern Project, llc in advance of Exhibition.

5. Duration of Consignment. The Artist agrees that the initial term of consignment for the Artworks is to be _____, and that the Artist does not intend to request their return before the end of this term. Thereafter, consignment shall continue until the Artist requests the return of any or all of the Artworks or The Contemporary Art Modern Project, llc requests that the Artist take back any or all of the Artworks with which the other party shall comply within 10 days.

6. Responsibility for Loss or Damage, Insurance Coverage.

The Contemporary Art Modern Project, llc shall be responsible for the safekeeping of all consigned Artworks while they are in its custody. They shall be strictly liable to the Artist for their loss or damage (except for damage resulting from flaws inherent in the Artworks). * All shipped artwork must be photographed with a condition report to be sent with the shipment.

7. Fiduciary Responsibilities. Title to each of the Artworks remains in the Artist until the Artist has been paid the full amount owing him or her for the Artworks; title then passes directly to the purchaser. All proceeds from the sale of the Artworks shall be held in trust for the Artist - The Contemporary Art Modern Project, llc shall pay all amounts due the Artist before any works are given to the purchaser.

8. Removal from Exhibition. The exhibition shall not lend out, remove from the premises, or sell on approval any of the Artworks, without first obtaining written permission from the Artist. If the artist does not comply with the dates of removal, the artist grants permission to The Contemporary Art Modern Project to remove the work - and the artist agrees to absorb additional costs should there be any. All works

left in the possession of The Contemporary Art Modern Project, without notification for more than 90 days will be considered abandoned.

9. Pricing, Commission & Terms of Payment. The Contemporary Art Modern Project, llc (in collaboration with the artist) shall sell the Artworks only at the Retail Price specified on the Inventory Sheet. Prices should be the same as those published online to allow The Contemporary Art Modern Project equally opportunity to sell the works and not compete with other: websites or galleries. Both parties agree that The CAMP Gallery shall receive the agreed commission of 50% as stated in the artist's representation contract.
